



Lengthen the life of your clothes dryer with regular cleaning. Clean the lint filter after every load, which improves air circulation and safety. Check the lint trap opening to ensure it's clean. Use a vacuum to remove any lint that's fallen inside the opening.

If you use dryer sheets, check the lint filter for residue buildup. Remove any residue with hot water and a nylon brush or toothbrush. Over time, dryer sheets can leave a film on the filter, which can affect the performance of the motor.

Wyoming Public Service Update!!!

Information on our Wyoming Public Service Commission changes for 2024.

The net metering avoided cost shall be established by utilizing the wholesale power supplier's avoided cost in accordance with Wyoming State Statute § 37-2-122 (d)(i) of the previous calendar year. This rate shall remain in effect for the entire previous calendar year, unless the wholesale power supplier increases or decreases its rates to Carbon, in which case the rate will automatically apply.

Net Metering Avoided Cost: The kWh rate will increase to \$0.02403 from \$0.01632 due to this adjustment. In accordance with Wyo. State S § 37-2-122 (d)(i), which states in part that a distribution cooperatives avoided cost is the wholesale power supplier's avoided cost.
