As a Member-Owner of Carbon Power and Light...will you do your part?

Off and on for several months now, either through this newsletter or through informative articles in the WREN magazine, you have been provided data regarding the proposed Environmental Protection Agency's (EPA) new climate regulations. These new regulations, as proposed, will have a dramatic impact on our nation's ability to utilize coal as an electric generation resource. I am sure that I can safely say that everyone reading this article is as concerned about our environment as I am. Nobody wants to see our air quality or quality of life diminish. Our concerns however, must be tempered with a measure of common sense. Currently over 40% of our nation's electric generation is produced using coal. Updating existing coal fired power plants and attempting to construct new coal fired power plants under the new regulations will economically impact each and every one of us.

So...just how much could that impact be? Recently Dr. Julio Friedmann, Deputy Assistant Secretary for clean coal at the Department of Energy told House Lawmakers in Washington that the first generation of carbon capture and storage technology required by the new regulations could increase wholesale electricity prices by 70 to 80 percent. The wholesale energy component makes up approximately 70 percent of

Carbon's retail rate, or said another way, about \$0.70 of every dollar that Carbon derives from your monthly electric bill goes to pay our wholesale power bill. Based on our current cost of service. increasing the wholesale component of our retail rate by 70 percent, would change our current per kWh charge of \$0.113163 to \$0.1686127. A Member-Owner using 2,000 kWh per month could see a \$111 increase in their monthly electric bill or an increase of \$1,331 per year.


Member-Owned Electric Rural Cooperatives like Carbon have always faced the challenge of meeting our operational needs while doing all we can to keep our rates as low as possible... while at the same time, meeting the challenges of serving difficult terrain and rural areas with low consumer density (in Carbon's case an average of three consumers per mile of power line). Having our Federal Government mandate changes such as the proposed EPA regulations, places an increased burden on...all of us.

ENJOY A SAFE START TO SPRING

As the spring season approaches, many will usher in the warmer weather by thoroughly cleaning their homes and tending to yard work. The Electrical Safety Foundation (ESFI) recommends homeowners ensure that electrical hazards are eliminated along with unwanted dust and clutter.

ESFI suggests starting with the basement, an important, but often overlooked space when it comes to home inspection and fire safety. These low-level rooms contain two leading causes of home fires - heating equipment and electrical distribution systems.

- · Check the label inside the door or cover of your electrical service panel to see when your electrical system was last inspected. If the date has passed or is approaching, contact a licensed, qualified electrician to schedule an inspection.
- Be sure circuit breakers and fuses are correctly labeled with their amperage and their corresponding rooms, circuits or outlets. Use correct size and current rating for breakers/fuses.



- Increase your fire protection by having a licensed electrician replace your standard circuit breakers with arc fault circuit interrupters - AFCIs.
- Have your furnace cleaned and inspected annually by a licensed professional.
- Make sure all fuel-burning equipment, such as furnaces, stoves, and fireplaces, is vented to the outside to avoid carbon monoxide poisoning.
- Check for excessive vibration or movement when the washing machine or dryer is operating. This can put stress on electrical connections.
- Make sure the area around your dryer is clutter free and that the dryer lint filter is cleaned after each load. Build up can be a fire starter.
- Don't overlook your basement when it comes to smoke detectors and carbon monoxide detectors. These devices should be installed in these spaces as well as on every level of your home and outside every sleeping area. Test these alarms to ensure that they are in working order, and replace the batteries when needed.
