Cooperative Business

OUTAGE:

Carbon recently experienced an unusual outage situation that impacted our Member-Owners in the Elk Mountain, Rock River and Medicine Bow areas. During the outage, Carbon's crews patrolled our 34.5 kV powerline that serves out of the Western Area Power Administration's (WAPA's) Medicine Bow Substation to determine the cause of the outage. In short order they found that the water levels in East Allen Lake had risen and expanded westward engulfing our power line as well as WAPA's power line serving the wind turbine site south of Medicine Bow. Windblown lake ice had then pushed one of Carbon's poles over causing the outage and creating a difficult and somewhat dangerous situation for Carbon's crews who attempted to make repairs. Because of the water level and the fact that the ice had not only leaned the pole over, it had moved the base of the pole nearly 15 feet. Carbon's crews, using a boat, were able to reach the downed pole and untie the conductors. Because this increased the span length between the remaining poles, insulated link sticks (spacers) were put between the three conductors in an effort to keep them apart in the


event of high winds occurring prior to the crew being able to make a permanent repair. As of this writing, Carbon's engineering department has been working with WAPA, Tri-State, the Bureau of Land Management and Anadarko Petroleum to establish a reliable/temporary solution to maintain service and to establish a new right-of-way and a re-routing of the line to higher ground around the west side of the lake. Construction materials are being hauled to the site and work will commence immediately once everything is in place.

AS RANCHERS AND FARMERS MAKE PLANS TO RETURN TO THEIR FIELDS FOR SPRING WORK, CARBON POWER & LIGHT URGES THEM TO BE MINDFUL OF THE DANGERS OF WORKING NEAR OVERHEAD POWER LINES. OPERATING LARGE EQUIPMENT NEAR THESE LINES IS ONE OF THE OFTEN OVERLOOKED, YET POTENTIALLY DEADLY, HAZARDS OF WORKING ON THE RANCH OR FARM.

Start by making sure everyone knows to maintain a 10-foot clearance minimum from power lines. High voltage requires more clearance. Sometimes a power line is closer than it looks. Helpful safety steps include using a spotter and designating preplanned routes that avoid hazard areas.

Be aware of increased height when loading and transporting tractors on trailer beds. Many tractors now have tall antennas extending from the cab that could make contact with power lines. Avoid raising the arms of equipment near power lines, and never attempt to raise or move a power line to clear a path.

Simply working too close to a power line is dangerous as electricity can arc or "jump" to conducting objects, such as a ladder, pole or truck. Remember, non-metallic materials such as lumber, tires, ropes and hay will conduct electricity depending on dampness, dust and dirt contamination. For those who irrigate, do not spray water on power lines, equipment or structures. The stream of water can also conduct electricity.

If your equipment does come into contact with power lines, stay in the cab and call Carbon Power & Light for help. If the power line is energized and you step outside, your body becomes the path to the ground. Even if a line has landed on the ground, there is still potential for the area to be energized. Warn others who may be nearby to stay clear and wait until help arrives.

If exiting the cab is absolutely necessary because of fire, the proper action is to jump—not step—with both feet together, hitting the ground at the same time. Do not allow any part of your body to touch the equipment and the ground at the same time. Hop to safety, keeping both feet together as you leave the area.

Time-of-Day Rates End June 1st!

What are time-of-day rates?

Time-of-day (TOD) rates are off-peak rates that are lower than the residential on-peak kWh rates and are for Members who have purchased Electric Thermal Storage (ETS) heating system.



The ETS program is designed to encourage lower usage during peak times of the system's energy consumption.

How does the TOD rates work?

Time-of-day rates work by billing the actual cost of making and delivering power at different times, meaning power is the cheapest overnight, or in the early afternoon hours when the overall demand on the system for electricity is lower (off-peak).

How do I qualify for the TOD Rate?

In order to qualify for the TOD rate you must have an electric-based ETS heating system that has the capacity to store heat with appropriate timing and controls.

Where can I purchase an ETS system?

Carbon Power & Light can assist you. Call the office and ask for Member Services.
