

Carbon is currently conducting a cost of service study to determine the appropriate rates for all classes of electric service. We are expecting a rate increase of 6.3% form Tri-State and are currently experiencing lower residential sales impacting our margins. At the annual meeting I announced an anticipated 4 to 5% rate increase for 2025.

The Cost of service study will evaluate our revenue requirements, the expenses each rate class requires and the required rate from each class. There is a lot of data to review and analyze to get to a good solid rate plan.

In April the Board approved a new rate for transmission connected renewable projects that require

standby service. This rate is named Station Power Service or SPS for short. The Rate added a demand component to the rate and lowered the kWh charge. The rate takes affect for July usage. Demand is the time that an electric service uses its peak kW for the month or a given period. Tri-State bills Carbon's demand in a peak period. The peak period is from Noon to 10pm, interestingly our SPS members contributed enough to set our peak demand in June. The SPS rate will also be evaluated in the cost of service study.
